And there are over 450 million others like me who are dependent on forests across Asia.


Investing in us is for everyone's benefit.


Because when the land falls ill, so do I.

I am the Forest.




Invest in me by developing participatory processes in forest management. Local communities need mechanisms such as public hearings, consultation meetings, multi-stakeholder platforms, and participatory monitoring and implementation. Awareness-raising and information access is a pre-requisite to informed participation by local communities. Millions of rural communities live in and around forests, and we have been sustainably managing forest resources for decades. Our insights and ability can help develop and deliver on effective policies for sustainable forest management.



Invest in me, so I can develop and implement sustainable forest enterprises. Local communities need access to different kinds of capital in order to access markets, and technical skills to add value to forest products and services. When local communities are able to use forests for our livelihoods, forests are healthier.



Invest in me, invest in processes to recognize and formalize rights in community-based forest management. This includes support from national to local government, the private sector, and others. When local communities have tenure, we can protect our forest from encroachment and illegal logging – resulting in lower deforestation rates than even protected forests.



Invest in me, invest in effective and relevant capacity development programs on sustainable forest management that are based on local communities' needs. More effective capacity development programs for local forest managers must be developed in terms of building upon our existing capacities through training on new technologies, local communities' networking among one another and other stakeholders. When we have the capacity to comply with forest regulations and make a living from our forests, we can and will sustain our forests.

WHY **COMMUNITY FORESTRY**

Community forestry (CF) is used to describe models of forest management that place local people at the center of decision-making. CF delivers sustainable forest management, meeting the growing needs of society. To maximize its potential, fundamentals such as participation processes, tenure rights, resources allocation and capacity development must be in place.
